INVESTMED ABOUT

MSMEs in the Mediterranean region face important challenges in terms of sustainability, capacity to innovate, competitiveness and internationalisation. These challenges call for new solutions in order for MSMEs to maintain their existence and to enhance growth. Making the economy greener, developing natural assets and enhancing innovation and creativity can provide economic, knowledge-based and environmental benefits to the Mediterranean region.

INVESTMED addresses economic and environmental challenges, supporting sustainable, creative and innovative business opportunities for young people and women in Egypt, Lebanon and Tunisia. INVESTMED is set to benefit MSMEs via training, coaching and sub-granting. It will also provide support for public authorities by enhancing their capacities to encourage and to facilitate MSME access to Intellectual Property Rights (IPR).

INVESTMED has a duration of 30 months, with a total budget of €3.8 Million, of which €3.4 Million (90%) is funded by ENI CBC MED

INVESTMED OBJECTIVE

INVESTMED aims to support the development of sustainable entrepreneurship and business initiatives, by creating a strong business environment and by facilitating access to new markets, with the ultimate goal of generating increased economic opportunities and jobs for young people and women in Egypt, Lebanon and Tunisia.

Sustainable Business Management training course

Call for trainees launched

On 24 June 2021, INVESTMED launched a call to recruit participants in a training programme on Sustainable Business Management (SBM), aiming to positively impact start-ups and Micro, Small and Medium-sized Enterprises (MSMEs) in the green economy sector, the blue economy sector, and creative and cultural industries (CCIs).

The objective of the training is to create a supportive environment for sustainable businesses in Egypt, Lebanon and Tunisia in order to increase the share of cross-border MSMEs and start-ups, with a particular focus on those managed by young people and women.

The programme is delivered by LUMSA University (Italy) and features teaching and research staff from LUMSA as well as other, research institutes and international organisations.

The training programme will run for a total of 12 months, with a blended learning approach combining both synchronous and asynchronous online teaching. It will run in Egypt, Lebanon and Tunisia.

The call aimed to recruit owners of start-ups and MSMEs in the green economy, blue economy, and creative and cultural industries, as well as potential entrepreneurs in these sectors and those with digital ideas. Applications were particularly welcomed from women and from young graduates (24-25 years old).

Campaign

The call was published in English, French and Arabic and promoted on INVESTMED's social media and by partners. A Facebook campaign focusing on the target group of the call reached over 100,000 Facebook members. Over 200 trainees were accepted onto the course, 59% of them women. 42 trainees will take part in the first cycle of training, and the rest in subsequent cycles.

Training programme kick-off


The first cycle of the training programme was officially inaugurated in Egypt on Wednesday 15th September, in Lebanon on Thursday 16th September, and in Tunisia on Monday 20th September. The programme welcomes 42 trainees, both current and potential entrepreneurs and business owners in the green economy, blue economy, and creative & cultural sectors.

The event for Tunisia opened with a welcome address by Ms. Asma Chebbi, Monitoring, Evaluation, Accountability, and Learning Coordinator of BUSINESSMED, the leading partner of the INVESTMED project. In Egypt, participants were welcomed by Dr. Alaa Ezz, Secretary General of the Confederation of Egyptian-European Businesses, and Lebanese trainees by Ms. Natalia Menhall, founding partner and chair of Beyond Group.

During the inauguration sessions Prof. Giovanni Ferri and Flavia Vighini from LUMSA University presented an overview of the training programme, which includes online modules, coursework based on real business cases, live webinars, and individual coaching and mentoring, with the opportunity to meet investors and apply for subgrants.

Professor Ferri said, "We are excited to kick off this first round of training to boost business knowledge and sustainability in these three important sectors in the Mediterranean. Our participants come from a wide range of backgrounds, with a great diversity of businesses and business ideas, and we look forward to fruitful outcomes from this and future cycles."

Furthermore, Alexandra Chimona from IED presented the e-learning platform developed by IED specifically for the needs of the project, and Dr. Cynthia Echave from EMEA presented the INVESTMED Community Building and Engagement platform which aims to support trainees in their learning and help entrepreneurs enhance their visibility and build networks.



Consultations

INVESTMED conducted consultations with Business Support Organisations (BSOs) in Lebanon and Tunisia, discussing how young entrepreneurs in the green economy, blue economy, and cultural & creative industries can best be supported.

30 March 2021 - Lebanon


The first INVESTMED consultation session was attended by 19 participants, with representatives of 7 leading Lebanese BSOs active in green and sustainable entrepreneurship. The session was chaired by the INVESTMED partner in Lebanon, Beyond Group. Key takeaways included the ongoing economic, financial and health crises in Lebanon impeding the survival of young businesses, and the high cost of registration with the National Authorities for companies, leaving any entrepreneurs in the informal sector with no access to social security, public health provision, or other benefits of legally registered companies.

On the other hand, the unprecedented devaluation of the national currency has created an opportunity for exporting, as the prices of local goods are now more attractive for foreign buyers, and the demand for local products has increased.

31 March 2021 - Tunisia

There were 18 participants, with 3 BSOs, present in the session for Tunisia, which was chaired by INVESTMED's lead partner, BUSINESSMED.

It was noted that young entrepreneurs needed strengthened business management skills such as negotiation and decision making. This is of particular importance for young women, as the market is dominated by male businessmen.



Outcomes

The INVESTMED training programme will enhance business management skills, support access to local and foreign markets, and focus on economic and financial sustainability. It will encourage young entrepreneurs in Lebanon to legally register their companies in order to join and contribute to the formal economy and have access to public health services and social benefits.

6TH May 2021
